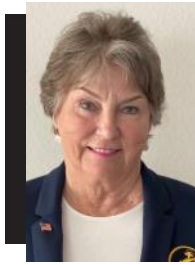

WSB Pen update:

The rehabilitation of the White Sea Bass Growout pens is finally done. We have removed and replaced the predator net with a new one. This one is secured to the float sides by screwing 2x4 pressure-treated lumber on top of the net, pinning the net between the sides of the deck and the 2x4s. Then we secured the chain link fence to the top rope of the predator net creating a gapless connection that should foil any intruding sea lions or birds.

We now expect to receive our 1st delivery of juvenile WSB tentatively set for Thursday March 12th. I will send out an e-mail blast letting everyone know the details. Come to the Anglers' Annual Lobster Dinner, enjoy the food, and thank those who worked on and /or donated to the rebuilding of this Critical Ocean Resource Enhancement facility.



The season for boat-based Rockfish and Lingcod starts March 1st!

Take of these species is prohibited seaward of the 75-fathom depth contour (450 feet), as defined in federal regulations (50 CFR Part 660, Subpart C). The daily bag and possession limit is 10 fish in combination with all species within the RCG Complex (includes all species of Rockfish, Cabezon and Greenlings) per person, with a sub-limit on Black Rockfish (4 per person) and Canary Rockfish (3 per person), also included in the 10-fish RCG Complex aggregate limit. Yelloweye Rockfish, Bronze-spotted Rockfish, and Cowcod may not be retained (bag limit: zero).

Wuhan Corona Virus

Corona viruses are a group of viruses which cause illnesses in mammals and birds. In humans the viruses produce respiratory infections. These are often mild – one example is the common cold. Others in the group cause severe infections, often deadly, such as SARS-2003, and the newly discovered corona virus from China, now labeled COVID-19.

Infected patients present with chills, fever, upper respiratory infection, muscle pain, and pneumonia. The virus was likely introduced from bats or pangolins to humans. Now there is human-to-human airborne transmission. Microdroplets containing the virus, from coughing or sneezing, linger in the air long enough to get into someone else's nose. The virus may land on surfaces such as doorknobs, computers, railings, etc., and be viable for an unknown period of time. This is very similar to the way the flu virus spreads.

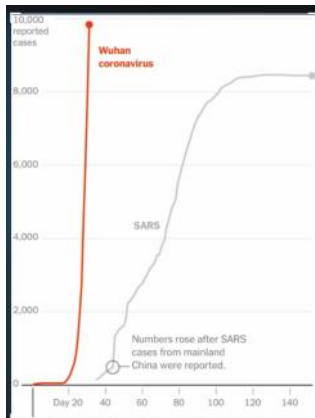
The incubation period is from 2 to 14 days. During that time the patient does not appear ill, but is still highly contagious to others. It is calculated that one patient is likely to infect two to three nearby individuals.

Some 82% develop a mild form of the disease, 15% are severe, and 3% are critical. It seems similar to the Spanish Flu of 1918, when millions died.

The graph on the left shows the comparison of the number of patients infected with SARS in 2003, to the number of patients infected with COVID-19 during the same span of time. The steep curve prompted WHO to declare an emergency, resulting in travel restrictions and other preventive measures.

The corona viruses have RNA as their genetic material, rather than DNA. That allows them to mutate more easily. Indeed, in one infected family of six, the virus had mutated several times (Lancet). Such mutations make it more difficult to bring under control. A nucleic acid assay test detects the virus, but the test is complex and requires competent lab technicians.

Individually, to prevent transmission of both flu virus and corona virus, stay home if you are sick (self-isolation), call your doctor's office with your symptoms and listen to his or her advice on how to proceed. Avoid smooching and close hugging, wash your hands often, don't touch your eyes, nose or mouth, avoid large congregations of people, and have a face mask ready if it becomes necessary. The virus can be transmitted 6' from the carrier! Sex? No sex! Remember, even if you think you have a cold, it could be a mild expression of the new Corona virus and you could become a superspreader of the disease.

Will it spread and come to the US? Many experts believe so, because it is highly contagious. Some even predict that 60% of the world's population could be affected. The mortality rate is 1-2% - you do the math. On the other hand, some epidemiologists downplay the likelihood of a pandemic reaching this country. No one really knows. If worse comes to worse and COVID-19 comes here, we may have to close the club for a month or two. Imagine the damage to bar revenues. Consider having basic food supplies at home that will last for two months. Also, keep an eye on the news. Things are developing too fast. Cheers, everybody.

County Files for an Override of Oxnard's Denial of Fisherman's Wharf Massive High-End Apartment Complex

In a letter dated January 27, 2020, the Harbor Director, Mark Sandoval, filed a request that the California Coastal Commission approve the Fisherman's Wharf Project Local Coastal Plan Amendment (LCPA) that Oxnard denied in November 2019.

The County is asking that the Coastal Commission overrule Oxnard's jurisdictional authority and approve its LCPA for its Fisherman's Wharf project. The County is contending that the purpose of the development is to meet public needs for an area greater than included in the LCP and that the development had not been anticipated at the time of the LCP certification.

The project has not materially changed since its approval by the County in June 2016. The project remains essentially a massive, high-end, exclusive 400-apartment complex at Fisherman's Wharf.

The importance of Channel Islands Harbor to an area beyond Oxnard is not at issue. That the redevelopment of Fisherman's Wharf will enhance the Harbor's appeal is also not at issue. At issue is the County's proposed LCPA attempts to accommodate a single project which violates the basic principle of genuine public access for all. The project creates traffic safety issues. The project removes over 30% of the existing park. The project reduces visitor-serving commercial and retail space by more than 40%, leaving only 5.4% of the total development building space as public. The project's amenities are overwhelmingly for the exclusive enjoyment of apartment tenants.

At issue are continual false claims and implied threats made by the County, even to the Coastal Commission. The County states in their January 2020 letter: "Should the LCPA not be granted, and the project fail, the site will likely remain in its current run-down state for many years while the County attempts to find a private investor willing to build a commercial site with no residential component." This has proven to be false. There is an unsolicited proposal that is a non-residential and visitor-serving commercial development from a company with an excellent performance track record.

The Override issue may be brought to the Coastal Commission during the Commission's hearings, April 15-17, in Oxnard. Those interested should plan to attend the meeting.



CIYC and Local Harbor Businesses Sponsored a Non-Partisan Community Forum for District 5 County Supervisor Candidates

On Monday, February 10th, candidates running to replace termed-out Supervisor John Zaragoza attended the forum. The meeting was sponsored by CIYC, Central Coast Electric Boats, and Arlene & Keith Studio Art Gallery.

Participating in the forum moderated by CIYC's Diane Sherlock were candidates Jeff Burum, Tim Flynn, Carmen Ramirez, and Veronica Robles-Solis. Surprisingly absent was Jess Herrera.

Candidates were prepared to respond to 3 questions as well as other ad hoc questions raised by the community attendees. The questions were:

1. The County and the City have had a troubled relationship for years, and this is evident in the County's refusal to substantially aid the city of Oxnard in cleaning up the harbor's water, including the polluted Kiddie Beach. How do you plan to get the County and Oxnard working together to resolve this and other issues cooperatively?
2. A lack of transparency in Channel Islands Harbor management and operations for more than a decade has created community mistrust of harbor and beach governance. This has been heightened by the proposed Fisherman's Wharf development. How will you restore community trust in the County's management of the harbor? Do you have a plan for the harbor and wharf?
3. What *other* one or two County issues are most important to you, and why?

The importance of the Ventura County District Supervisor races is reflected in the amount of money the California Resources Corporation, a leading producer of oil and gas interests, is spending: \$825,000 as of this writing. The money is being directed to support and influence specific candidates and oppose others. Money has been spent for candidates Kelly Long (District 3), Tim Flynn (District 5), Matt LaVere (District 1), and recently Jess Herrera (District 5). Large amounts of funds have also been used to oppose Kim Stephenson (District 3) and Carmen Ramirez (District 5).



It started 60 years ago!

I have been asked to be club historian this year, and to my mind it means I should dig into some history. What would be more important this year when we are celebrating our 60th anniversary than to look back at how we came to be? With the help of old yearbooks, Wendell's old documents, stories, and what past historian Bev Hamilton wrote, I am going to try my best.

First, a little history of Channel Islands Harbor: Originally, the plan was to add a recreational harbor section to Port Hueneme, but World War II stopped that when the government confiscated it and made it a Naval Base. The decision was made later to excavate a small harbor farther west to stop sand erosion out of Port Hueneme. At that time, the new harbor was called Ventura County Small Craft Harbor.

In late fall of 1959 the New Harbor Manager sent a letter to a group of men asking if it were possible to form a club in Channel Islands to get more recreational boaters to come there - in order to build more interest in the harbor. A meeting was set up for Nov. 24. A group of 20 interested men came together and made the decision to go ahead. H. Catlin was elected chairman and called for a meeting on December 8 when 16 of the group met to organize the first yacht club in Channel Islands. Trying to decide on a name, some felt that they should use the name which was given to the Oxnard Beach area: Channel Islands, while others wanted Anacapa. The vote was 9 to 6 for Channel Islands Yacht Club; one person failed to vote. They also nominated 9 Directors to the Board.

In the beginning, CIYC had their meetings at the Oxnard Beach Chamber of Commerce Building. They held special events and installations in places like the Elks Club and the Colonial House. At their first meeting in January of 1960, they decided yearly dues would be \$9, they filed articles of incorporation, changed the title of Chairman Catlin to Commodore, and submitted a design for a Club Burgee. They also sent a letter to the County Supervisors requesting consideration for a site to build the yacht club and a minimum of 200 future slips to be reserved for the members. One year later the supervisors turned them down for the site, and the docks were slow in coming.

By the spring of 1962 the Club had 192 members, with Ralph McKeehan as Commodore. They wanted to be able to moor their boats in the harbor. There were no docks or moorings yet, and they proposed to install 40 temporary moorings, ranging in size from 20 to 40 feet, which the supervisors agreed to. That meant many of the members would be able to bring their boats down from Santa Barbara where they were anchored. There were 185 people on a waiting list for permanent dock space. The deal ended up for CIYC to be the contracting agency, and to collect 20 cents per foot monthly, prepaid quarterly. Boat owners would pay the cost of the moorings, running \$225 for 20' to 30' and \$240 for 31' to 40' for full installation; \$50 if you provided the mooring equipment yourself. The county would provide parking, chemical toilets, and a landing float.

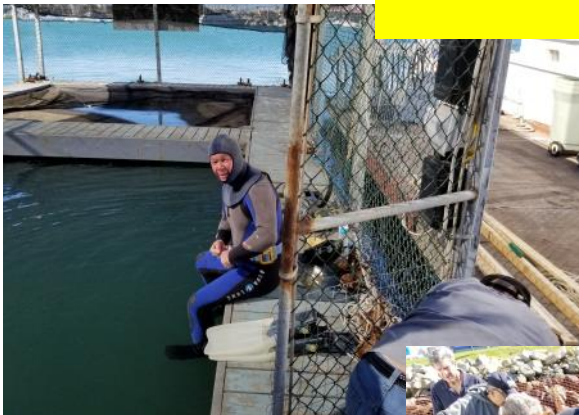
