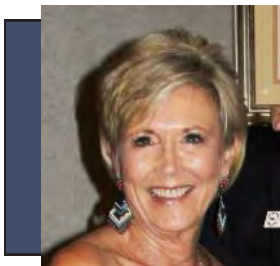

## Anglers' Corner - January 2019

Anglers' dues of \$10 for the 2019 fishing season are now due. Please send in your Anglers' dues with your regular club dues billing. Or they may be paid by notifying us and we will charge your account in the Point of Sale system. If you forgot and sent the dues in without the Anglers' dues, you can provide a SEPARATE check made out to "Channel Islands Yacht Club" and put **Anglers' Dues** in the memo section of the check. Mail it or bring it to the Club.

We intend this to be an exciting and fun-filled year. If you are a current member you know the drill, but for those of you who are new and may want to join in the fun, here are the details:

For only ten bucks you will be able to participate in the Club's Tournaments, be eligible for the ***\$50 Big Fish of the Month Award***, and also eligible for the ***\$100 Big Fish of the Year Award***.

Many months sometimes go by when no, or very few fish, are weighed in. This means that a ¼ lb. mackerel may be worth \$50, so weigh him in! An Angler can only win the monthly prize once a year, so we should have 12 different winners.

## Updates on Harbor Issues at Start of 2019

Here is the status of harbor projects and issues as the new year begins.

### County Fails to Provide Required Information for Fisherman's Wharf 400-Apartment Complex, Continues to Delay City's Review Process

For over one year now, the County has failed to provide the information needed by the City of Oxnard to process its application for a Local Coastal Plan Amendment (LCPA). Without this information, the City cannot perform a reasonable and public review of the project. Back in October 2017 the County was directed by the Coastal Commission to obtain an LCPA from the City. After the November 2018 meeting with the City and Coastal Commission, it is hoped that the County will submit the required information any LCPA applicant must provide the City. If the County chooses not to do so, will it drop the project or continue to try and circumvent the City's jurisdiction and ignore the Coastal Commission's October 2017 directive.

Refusal to deliver the required information and to issue only threats of litigation, reinforces suspicions about the appropriateness of the County's proposed 400-apartment project.

### Hotel Replacement Faces More County Delays

The public has supported the hotel replacement project since it was proposed in March 2016. But County actions have continued to hold up the building of the hotel, and it appears the project's start will be delayed for at least another year or so. Here is an overview of the major delays:

First, the County granted Channel Islands Properties LLC (CIHP), the Fisherman's Wharf apartment developer, an Exclusive Right to Negotiate (ERN) for the exact same land site as Brighton Management (the hotel developer for the proposed Hyatt Place Hotel). This ERN was used to pressure Brighton to allow space for CIHP's "undetermined development project" on the same land parcels originally approved solely for the hotel. They also did this to get the height variance needed for their anticipated apartment developer's project on the Peninsula.

Second, the approved "hotel project design" requires the City to give up land for the hotel to meet its parking requirements and allow land space in the future for CIHP to build its "undetermined development project." The City supports the hotel project but without the County's submission of an application for a "street vacation permit," the City is again unable to process their request for use of City land. If the County or developer does not apply for this permit, there will be another delay because Brighton will be forced to redesign its hotel plan in an attempt to accommodate and allow space for the apartment developer's (CIHP) "undetermined project." Parking is and will continue to be a huge issue on Peninsula Road with already over 400 apartments, hundreds of condos and a popular community park.

Third, in December, the Harbor Department found more rock revetment repair was needed than estimated by the County. This is inexcusable incompetence or a deliberate delay, as the Harbor Department has had almost 3 years to identify and resolve this issue. We are told this could be a 6-month repair job. However, before repairs can even take place, the old Casa Sirena Hotel must be removed because the repair work will be done from landside. This means Brighton would need a permit to demolish the hotel. After that the revetment repair could start. It now appears the hotel project will be delayed for at least another year or more. This again reveals how hollow the County's rhetoric is on the need for harbor revitalization.

### **Restoring and Maintaining Water Quality at the Harbor**

Causes, including the shutting down of the power plant, are being scientifically investigated. Grants to subsidize the cost of restoring and maintaining water quality can be pursued once the study is completed and the causes identified. It is apparent that at this time, the option of turning the power plant pumps back on is not viable. Furthermore, NRG Energy has also pulled its 2015 application to build the Puente Power Project in the Mandalay Generating Station. This makes any cooperation from NRG more unlikely as well. The City is currently considering its legal options regarding the removal of the power plant. Perhaps a solution could also be incorporated in this endeavor. More to come after the study findings are published. In the meantime, the City has installed several aerators within the harbor to help with water circulation but this is not a long-term solution to preventing poor water quality. Global warming and climate change will also impact the harbor over time.

### **Whale's Tail Lease Agreement Settled**

It has been nearly two years since the original announcement that Fresca II would be opening at the deteriorating Whale's Tail restaurant building. Finally, the Harbor Department has confirmed the lease terms have been agreed to. The terms will be submitted to the Board of Supervisors in January or February 2019 at the latest. The terms should be publicly available at that time. However, the Harbor Department was either unwilling or unable to identify the key factors on which their selection of Fresca II was based. This is especially important for the public to understand as to how decisions are made in selecting a lessee for a specific harbor facility or service. In the future, such factors should be made public at the time the County is requesting proposals, not after the selection has been made. All proposals should be made public.

### **Interesting Article in the December 14-27 The Log re: Huntington Harbor as the Region's Last Waterfront and Waterway to Establish a Formal Harbor Commission**

The article claims that Huntington Harbor is the *last harbor* to establish a formal Harbor Commission to oversee everyday issues affecting boaters and other users of the harbor. The article, though incorrect in this fact, goes on to explain the importance of having a harbor commission. With so many ocean and environmental issues such as rising sea levels, water quality, recreational safety, general infrastructure and facilities, environmental justice, codes, etc., Orange County recognized there was a need for a commission. A commission can gather information, involve stakeholders, help analyze issues from diverse perspectives, and contribute to the development of a long-term harbor plan.

Like Orange County, Ventura County faces many of the same issues; risk assessment of rising sea levels is one of them. But County Planning has strangely excluded Channel Islands Harbor from its study of Resilient Sea Level Vulnerability Assessment. This results in duplicating efforts/costs and the Board of Supervisors relying on one Harbor Director's advice and piecemeal planning tactics. Will Channel Islands Harbor be the real last harbor to establish a Harbor Commission of elected stakeholders?

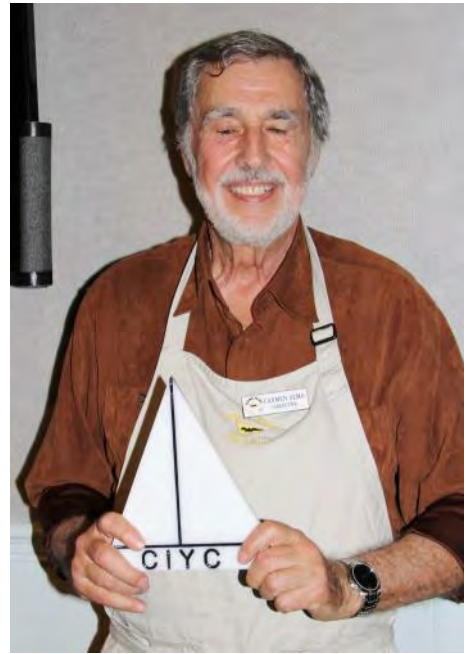

## Doc Lines

### Influenza: 2017/2018

Some 80,000 Americans died from the H3N2 flu last year. This is more than three or four times as many compared to an average year. This was also the largest number since the pandemic of Spanish flu in 1918/19 when it is estimated that 500,000 Americans perished. The flu was supposed to be less virulent this year, but it seems to be more severe than expected. However, the vaccine is much better. The peak of flu season is expected in January and February. Wash your hands often and don't touch your face, eyes, and nose. Please try not to hug and smooch too much! Get vaccinated.

### Being Unfit

"Being unfit should be considered as strong a risk factor as hypertension, diabetes, and smoking—if not stronger than all of them." This is in a study from the Cleveland Clinic published in JAMA. "It should be treated as a disease that has a prescription, which is called exercise." What did I tell you? Start some form of exercise and get in shape. But talk to your doctor first and start slowly.

### Second Opinions

This is from the Mayo Clinic. A new study finds that 88% of people who go for a second opinion after seeing a doctor are likely to leave with a refined or new diagnosis compared with what they were first told by their primary physician. Therefore, the second opinion specialist only confirmed the original diagnosis 12% of the time. Considering how health insurance companies often limit the ability of patients to visit multiple specialists, this figure is troubling.

### Motion Sickness

Now this may be of interest to our club members who get seasick. The Naval Aerospace Medical Research Laboratory found that more than half of soldiers riding in Army vehicles suffer from motion sickness. Roughly 25% of sailors get sick in "moderate seas," and 70% in "rough seas." And 50% of personnel, including paratroopers, get airsick. To combat motion sickness, troops typically take a drug called scopolamine which has side-effects.

A young inventor came up with an interesting solution. A headband attaches a small device behind one ear. The device emits subtle vibrations which target two nerve fibers that carry the data from the inner ear to the brain. The working hypothesis is that the vibration causes a chaotic and non-informative stimulus to go to the brain. Although it is not exactly clear how it works, it does prevent motion sickness without affecting balance, vision, alertness, or anything else. Not sure yet when it will appear on the market.

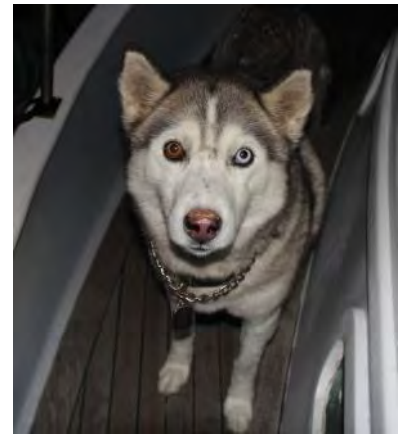

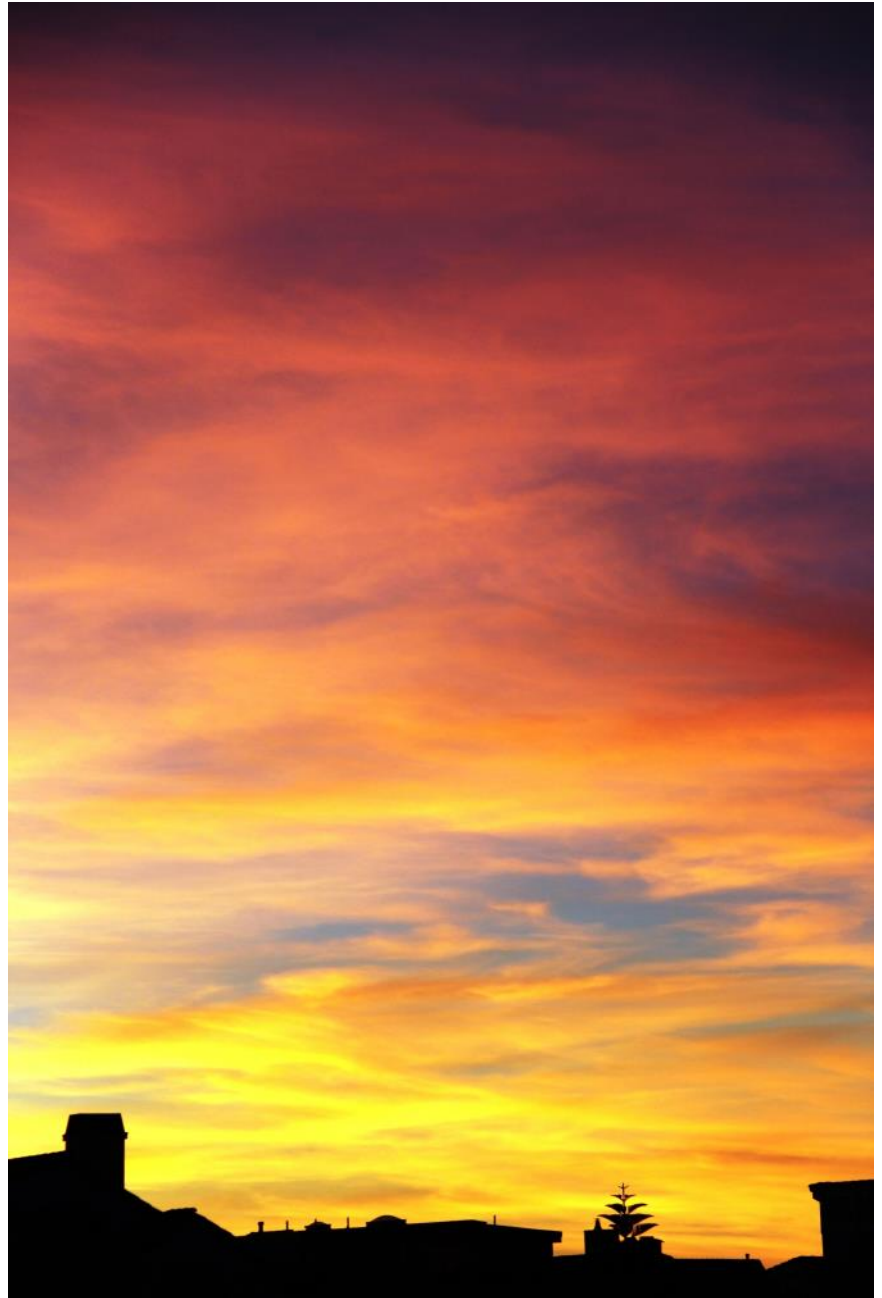
